A TRAINING OF TRAINERS ON CLF FINANCIAL PROJECTION AND WORKSHOP ON CO-OPERATIVE COMPLIANCE

A Two-Day Training of Trainers on CLF Financial Projection and a Workshop on Cooperative Compliances took place on the 19th and 20th. The event featured Resource Persons are NRP Alok Kumar Sahu for Financial Projection, Shri. RS Marbaniang, SCO/Instructor, and Shri. Shyam Chettri Chartered Accountant and the participants included SMM IBCB, SMM M&E, PM CLF, PM DF, YP IBCB, DFS IBCB, and CCs from 15 CLF immersion sites.

During the training, the financial projections of CLF immersion sites were reviewed, with 11 out of 15 completing their projections.

The Registrar of Cooperative Society discussed cooperative principles and emphasized the importance of maintaining accurate financial records. An open discussion covered the various compliances that CLFs need to follow.

Shri. Shyam Chettri provided insights on filing Income Tax Returns, a brief overview of GST, and the significance of PAN card registration for Cooperative Societies.

The program covered various topics such as KCC loans for livestock and pig insurance, MARDS scheme, CM Elevate, PMFME, MGNREGA schemes (Natural Resource Management and Non-Natural Resource Aadhaar Management), Seeding, Social Security Schemes, SHGs their loans. processes, repayments, and other aspects related to financial inclusion.

SUCCESS STORY



Kong Aitila Mawphniang: Lakhpati Didi's Transformation Journey

Introduction

Kong Aitila Mawphniang joined Shalyntem SHG on the 20th February, 2021. Prior to her joining she was primarily engaged in ginger cultivation, broomstick collection, and management of litchi and Myrica fruit orchards. Despite her efforts she could only earn Rs. 80,000 per annum from the activities.

Implementation:

Kong Aitila, after been engaged under NRLM fold, she has undergone different trainings such as training on Management of Ginger cultivation, Poultry and Pig rearing. This boost her confidence to upscale and expand her activity by taking a loan of Rs. 100000/- from the Cluster Level Federation (CLF) for procuring piglets, poultry birds and construction of sheds for poultry and pig.

Current Livelihoods Activities:

The current livelihood activities of kong Aitila Mawphniang, a farmer residing at Syad heh village of Umsning C & RD Block includes Poultry Rearing (Local & Broiler breed), Pig Rearing, Ginger cultivation, Broom stick collection, Litchi & Myrica Orchard management.
