**OFFICE ORDER**

In pursuance to the applications for transfer received from the staff of District Mission Management Unit (DMMU) and Block Mission Management Unit (BMMU) duly recommended by the Block Development Officers, Project Directors and Deputy Commissioners, the same has been placed before a Committee, chaired by the Chief Executive Officer of MSRLS.

The Committee has examined the validity of the request made and after due consideration, has approved the transfer of the staff given in Annexure -1, on the following conditions:

1. Although staff will be transferred to their home district or block, they are to ensure that the mandatory village stay of minimum 15 days, should be strictly adhere too.
2. To refrain from any form of nepotism or favouritism, towards a particular clan/community.
3. The performance of the staff will be monitored on a regular basis and assessment will be done.
4. The performance and achievement of the staff will be assessed every quarter, and base on the result, the transfer order maybe revoked and the staff will be transferred to another Block or District other than their home District.
5. The transfer order to home district does not supersede the mandate of the organisation, that staff recruited by MSRLS are transferable and hence staff should not consider transfer as permanent posting.

The staff concerned are to complete the handing-over process and settlement of all dues within thirty (30) days or earlier from the date of issue of this order. Release order should be issued from the DMMU/BMMU concerned, duly certified by the Reporting Officer and approved by the Deputy Commissioner.
